ELIGIBILITY

All active, full-time and domestic part-time employees of a Christian Reformed Church in North America or Reformed Church in America congregation, institution, agency or eligible affiliated organization regularly scheduled to work a minimum of 20 hours per week.

Dependents are:

- your legal spouse not legally separated or divorced from you
- your unmarried financially dependent children(1) from live birth to 26 years. Age limit does not apply to handicapped children.
- A person may not have coverage as both an Employee and Dependent.
- Only one insured spouse may cover Dependent children.
